<p>Virtual Learning - Individual Request: Permission must be given for children to attend our Catholic schools virtually in the 2021-22 school year. We believe it is best to have our students in person in our schools, whenever possible.</p> <p>Parents may make an application to the re-opening committee (not to the building principal) for consideration for virtual education. The application includes completion of a Google Form and an email including the needed medical documentation. Only medically-documented reasons will be considered. When the re-opening committee receives the application, the committee will consult with the building principal on the matter. The application, pertinent dates and email link can be found here.</p>	<p>Virtual Learning - Individual Request: <i>OMPH will require that all virtual learning requests be made to the reopening committee for the 2021-2022 school year. Medical documentation must be presented for consideration. Parents will need to complete the application through the google form link provided. The application, pertinent dates and email link can be found here.</i></p>
<p>Virtual Learning - Response to Exposure: If quarantine is needed for a group of students, the school will strive to accommodate that group through a combination of virtual and traditional learning methods. Schools need to be prepared to offer virtual instruction in case an entire class needs to be quarantined.</p>	<p>Virtual Learning - Response to Exposure: <i>In the case of an exposure to a specific group of students, OMPH will accommodate the group with virtual instruction. All students will have a device that can be used at home for virtual instruction. The virtual instruction will continue through the duration of the quarantine period.</i></p>

- Parents will be asked to be vigilant in checking students for symptoms of illness and to keep students home when ill.
- As details of specific symptoms of concern are known, the school will advise parents of any symptoms that require students to remain at home.
- Faculty and staff are asked to do a daily self-check for symptoms.

coronavirus and its variants:

OMPH will notify parents if their child has any of these symptoms once they arrive at school or develop them during the day. Parents must pick up their child promptly. Please be sure that you have the necessary arrangements for your child to be picked up so that we can continue to ensure the health and safety of all. Students may not return until they are fever/symptom free for 48 hours.

Faculty and staff will do a self check for symptoms each day before entering the building.

<p>Students are expected to be three feet apart in the classroom, to the extent feasible.</p>	<p><i>Every effort will be made at OMPH to utilize flexible seating arrangements to provide a three feet space between students in the classroom.</i></p>
<p>Masks: Masks will not be required in our schools for faculty, staff and students. They are optional for those who would prefer to wear them. Schools must ensure that that option is honored and respected.</p> <ul style="list-style-type: none"> • Students will follow the rules of their school district re: masks when utilizing district transportation. 	<p>Masks <i>Masks for students, faculty and staff will be optional. Students should carry a few masks in their book bags if they are required for their school district transportation to and from school.</i></p>

<p>Record of Vaccines: Principals will need to know the vaccination status of the people in the buildings in order to be aware of the overall health situation in the schools and to be able to make quarantine decisions, if needed.</p> <ul style="list-style-type: none"> • Faculty and staff in our schools will inform the principal about their vaccination status at the proper time and through the proper channels. • Parents of students are encouraged to let principals know, in the manner the school establishes, if children have been vaccinated. • In all cases, the school will take every reasonable precaution to safeguard the privacy and dignity of all students, faculty and staff regarding vaccination status. 	<p>Record of Vaccines: <i>Parents of OMPH students are encouraged to notify the school if their child 12 or older is vaccinated. Once the vaccine becomes available for children under 12 years of age, parents are encouraged to notify the school when their child is vaccinated. This will be kept confidential in each child's health record.</i></p> <p><i>Faculty and Staff will notify the principal of their vaccination status. This will be kept confidential in each teacher's health record.</i></p>

Quarantines:

We will await more information from the state to see if contact tracing and quarantine are required at all for those students and faculty and staff who are exposed to a Covid-positive person. We will assume that we will operate as we did in 2020-21 unless told otherwise.

Therefore, unvaccinated faculty, staff or students who are exposed to a Covid-positive person will need to quarantine based on time frames established by the CDC and adopted by the State of Pennsylvania. Fully vaccinated faculty, staff and students will NOT need to quarantine, and no contact tracing is needed. Clearly, any student or faculty or staff member who tests positive for Covid must quarantine, with the length of the quarantine to be determined by the Board of Health.

Parents, visitors and volunteers:

Parents, volunteers and other visitors will be allowed in schools.

- Those who are fully vaccinated will not be asked to wear masks.
- Signage will be posted prominently in the lobby/office indicating that parents, visitors and volunteers in our school who are not fully vaccinated are asked to wear masks while in the school.
- When signing in, parents, visitors and volunteers will sign that they understand and will comply with the request to mask if they are not fully vaccinated. No one will be asked for proof of vaccination when signing in.

Cleaning:

Faculty, staff, students who are not vaccinated and exposed to a Covid - positive person will need to quarantine based on time frames established by the CDC and adopted by the State of Pennsylvania.

Parents, visitors and volunteers:

Cleaning:

<p>Areas in schools for common use -- that is, used regularly by multiple groups within the school -- need to be cleaned regularly.</p> <ul style="list-style-type: none"> • Locker rooms, gyms, band and chorus areas, and any other spaces used by multiple school groups are to be cleaned in the middle of the week, ideally, but at least once a week. • Lunchroom surfaces need to be sanitized between lunch shifts. • Classroom desks and high-traffic areas should be cleaned daily at the end of the school day. 	<p><i>Specific personnel will be required to keep the common areas of the school clean on a regular basis throughout the day.</i></p> <ol style="list-style-type: none"> 1. <i>Bathrooms and common areas will be sanitized daily.</i> 2. <i>Hallways and high touch areas will be sanitized throughout the school day.</i> 3. <i>Our teachers will wipe down high touch surface areas within their classroom regularly throughout the school day.</i>
<p>Ventilation: Schools will make every effort to provide as much ventilation as possible in each classroom, as we did in 2020-21. Leaving windows and doors open in an appropriate manner is the simplest approach.</p>	<p>Ventilation: Windows and doors will be open to help circulate air throughout the classroom. The use of air conditioners and open windows and ceiling fans will help with the circulation of air in the classroom as well.</p>
<p>Handwashing and hygiene: Students will be asked to wash/sanitize hands at sensible times, as always: at start and end of the school day, before and after lunch, when they have sneezed or used the restroom, and as needed. Water fountains may not be used. Schools may ask students to bring water bottles to school.</p>	<p>Handwashing and hygiene: <i>Students will be encouraged to wash their hands often throughout the school day. Hand sanitizer will be available in the classroom.</i> <i>Information posters will be displayed to remind the children of the appropriate times to sanitize their hands.</i> <i>Refillable water stations have been installed and will be used by the students to refill their personal water bottles throughout the day.</i></p>

Field trips:

Reasonable field trips can be taken in the local area and that decision resides with the school. Proposed trips beyond the local area are to be brought to the Secretary for Education for discussion. However, the responsibility to vet the locations and situations encountered on these trips resides with the school. Schools will need to do homework and be sure of the situation students will encounter during the field trip: crowded areas, etc. -- and will prepare appropriately. High schools will be able to offer overnight retreats, as long as there is a thorough, written health and safety plan in place.

Field trips:

Field trips will be allowed this year and will be set up according to the policy on field trips in the parent/student handbook.

Social, emotional and spiritual care for students:

We need to make sure, in each school, that we are carefully monitoring student learning and providing all possible resources to meet individual learning needs and to provide the best resources for social, emotional and spiritual growth for our students. As we did last year, we will take a team approach in our schools: school nurses, counselors, social workers (if available) and priests will bring powerful resources to benefit our students. That team will need close collaboration with parents and with teachers, who know the needs of their students well.

Social, emotional and spiritual care for students:

Teachers will continually monitor the social, emotional and spiritual needs of their students. Concerns will be brought to the attention of the principal, pastor and counselor.

We will have an on-site nurse as needed, a counselor assigned to us from IU 13 and our pastor and associate pastor will be available as needed for spiritual direction.

Groupings: cohorts, assemblies, Mass, small group work

While we will not start the year with the strict cohorting system we used last year, each school is asked to plan the daily interaction of student groups. Each school will determine the range of those groups. In the end, if there is a potential exposure to Covid, we need to know how to proceed. As an

Groupings: cohorts, assemblies, Mass, small group work

Our students in grades pre-k through 5th grade will continue to work in self-contained classrooms throughout the day.

Our 6th through 8th grades will departmentalize for subjects and move between these classrooms for specific subject areas.

Every effort will be made to keep the students three feet apart in the classroom and during the transition from class to class.

<p>example: a school may decide that one group will be grades K-2, as they need to eat lunch at the same time.</p> <p>Schools may have small groups work together within the classroom. Maintain the three-foot distance, to the extent feasible.</p>	
<p>Groupings - Cafeteria: The cafeteria may be used. To the extent feasible, students should be three feet apart in the cafeteria. Commonly-used surfaces in the cafeteria must be cleaned between lunch shifts.
